## **ABOUT THE SPARTAN MEDICAL RESEARCH JOURNAL (SMRJ)**

The primary purpose of this peer-reviewed journal is to provide a formal publication option for research completed by MSUCOM students, residents and faculty. *SMRJ's* mission is to advance medicine and medical education through the timely publication of peer-reviewed clinically-oriented research, clinically-relevant basic science research, healthcare quality research, and medical education research from the MSUCOM community, with the ultimate goal of improving patient care and the education of patients and care providers. *SMRJ* is the official scholarly publication of the Statewide Campus System (SCS) of MSUCOM. It provides a forum for communicating research findings, clinical practice observations, philosophic concepts, and other biomedical and medical education advances to MSUCOM medical students, residents, fellows and faculty, and any other interested readers.

*SMRJ* is a free on-line journal, open to all viewers, housed on the MSUCOM Statewide Campus System website.

### **POLICIES**

*SMRJ* observes and operates in accordance with the *Recommendations for the Conduct, Reporting, Editing, and Publication of Scholarly Work in Medical Journals* established by the International Committee of Medical Journal Editors (ICMJE) (<http://www.icmje.org/icmje-recommendations.pdf>) and endeavors to adhere to all ethical guidelines contained therein.

#### Submission of Manuscripts and Copyright Policy

*SMRJ* accepts manuscript submissions from individuals or groups affiliated with the Michigan State University College of Osteopathic Medicine (i.e., medical students, residents, fellows and faculty). Submitted manuscripts should present the results of research or scholarly work completed by the submitting authors, using the format prescribed in the *SMRJ Information for Authors*. *SMRJ* accepts manuscripts for consideration with the understanding that they have not been published elsewhere in print or online and that they are not simultaneously under consideration by any other print or electronic publication. Shortly after submission, authors will receive an e-mail requesting them to sign and return a copyright agreement form. *SMRJ* is copyrighted by the Michigan State University Board of Trustees, and will follow the 2007 (or any later versions) of the Committee on Institutional Cooperation (CIC) *Statement on Publishing Agreements* (<http://www.cic.net/docs/default-source/library/authorsrights.pdf>), as endorsed by the MSU Academic Council in September 2007. Under this agreement, authors maintain non-exclusive rights to their publication, and six months after original publication will have the right to make digital versions of their publication available in other forums.

#### Peer Review Policy

*SMRJ* utilizes a single-blind review process. All manuscripts submitted to *SMRJ* are first reviewed by the Chief Editor. Submissions are then reviewed by two or more persons knowledgeable in specialties or subspecialties relevant to the manuscripts. Reviewers and editors are required to treat each manuscript as confidential information, and must not use knowledge of the work they are reviewing before its publication to further their own interests. If a reviewer is asked to review a manuscript from an author that is a student or colleague, or the reviewer has had any involvement in the project being presented in the manuscript, the reviewer is expected to notify the chief editor and recuse himself or herself from the review. *SMRJ* usually notifies authors of manuscript acceptance, revision requests, or rejection within 1 month of acknowledging receipt of manuscripts.

#### Conflict of Interest Policy

Authors are responsible for disclosing all financial and personal relationships that might bias or appear to bias their work. *SMRJ* uses a *Form for Disclosure of Conflicts of Interest* developed by the ICMJE to facilitate and standardize authors' disclosures ([http://www.icmje.org/downloads/coi\\_disclosure.pdf](http://www.icmje.org/downloads/coi_disclosure.pdf)). Editorial staff should recuse themselves from editorial decisions if they have conflicts of interest or relationships that pose potential conflicts related to manuscripts under consideration. Reviewers must disclose to the Chief Editor any conflicts of interest that could bias their opinion of the manuscript, and should recuse themselves from reviewing specific manuscripts if the potential for bias exists.

#### Human and Animal Rights and Informed Consent Policy

For manuscripts involving human or experimental animal investigation, the authors must identify the institutional review board or the institutional animal care and use committee

that approved the project and include the IRB or IACUC identification number and date of approval. If the study was determined to be “Exempt”, this must be stated and the date of the exemption letter noted. The authors must also state the manner in which informed consent was obtained from human subjects. Manuscripts involving human or experimental animal investigation that do not contain this information will not be accepted.

#### Public Registration Policy

For manuscripts on Phase III clinical trials, the trials must have been registered with at least one public registry before subject enrollment in the study. Other trials involving human subjects, including pilot studies, must meet this requirement if they have at least one prospectively assigned concurrent control or comparison group. (See Instructions for Authors)

#### Errata Policy

Honest errors are a part of science and publishing, and require publication of a correction when errors in prior articles have been detected. Any error of fact in an article should be brought to the attention of the editorial staff immediately upon discovery. *SMRJ* will publish a correction notice as soon as possible as a header for the online article, and then post the corrected version of the article, with the corrections noted, as soon as the corrected version is available. Errors serious enough to invalidate an article’s results and conclusions require retraction.

#### Letters to the Editor Policy

Letters to the Editor are accepted from those who wish to comment on or provide a dissenting opinion regarding articles that appear in *SMRJ*. Letters should be sent to the Chief Editor ([smrjeditor@hc.msu.edu](mailto:smrjeditor@hc.msu.edu)), should be focused and brief and identify the specific article being commented upon. Authors of the article being commented upon will be given the opportunity to respond in cases where a criticism or dissenting viewpoint is being expressed.

#### Appeals Policy

An author who disagrees with a decision to reject a submitted manuscript may file a written appeal with the Chief Editor stating reasons for the disagreement. Within one week of receipt, the Chief Editor will submit the manuscript in question to a second panel of three reviewers with expertise in the subject area of the manuscript and who were not involved in the initial review. At least two of these three reviewers will not be members of the *SMRJ* editorial board. This second panel of reviewers will return their reviews to the Chief Editor within two weeks of receipt of the manuscript. The Chief

Editor will then take the recommendations of this second panel of reviewers into consideration in making a final decision on the acceptability of the manuscript.

*SMRJ* does not accept advertising.
